The partnership has been **actively collaborating** through regular meetings to ensure alignment on the project's objectives and progress.

These meetings have been fundamental in coordinating the development of key outputs and reviewing the materials to be produced.

Another key milestone will be the development of the **ICWE Toolkit**, a practical tool designed to support caregivers, allowing them to access guidance on specific topics whenever they need it.
